2. All claims against invoices must be made within 60 days after receipt of service.
3. Copies of lost or misplaced invoices provided to the applicant may be subject to a \$ 20.00 charge.
4. Our policy is not to issue original copies of any supporting documentation.
5. NSF cheques will be subject to a \$ 25.00 charge.
6. Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice. In the event of any default, Mill Creek Motor Freight LP may (a) close the account and/or (b) accelerate payment of the full balance.
7. The information given in this Application and Agreement is warranted to be true and correct and given for the purpose of obtaining credit.
8. The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with whom the applicant has or proposes to have financial relations.
9. Upon determination that the customer's creditworthiness has changed adversely or does not satisfy current credit standards, Mill Creek Motor Freight LP may close or lower the credit limit of the account.
